Driving Directions

From Emeryville:

Take 80 West, follow signs for San Francisco.
Take Bay Bridge to San Francisco (toll bridge).
Keep Left, follow signs for San Jose/US 101 S/Airport.
Merge onto 101 South.
Take Exit 425B for Oyster Point Blvd. E.
Continue onto Oyster Point Blvd.
Use the Left lane to turn Left onto Veterans Blvd.
The venue will be on the Left side.

From San Jose:

Take 101 North toward San Francisco.
Take Exit 425B for Oyster Point Blvd.
Use the middle lane to turn Left onto Dubuque Ave.
Use the 2nd from the right lane to turn Right onto Oyster Point Blvd.
Turn Left onto Veterans Blvd.
The venue will be on the Left side.

From Hayward/East Bay:

Take 92 West San Mateo Bridge (toll bridge).
Use the right 2 lanes to take exit 13B to merge onto 101 North toward San Francisco.
Take Exit 425B for Oyster Point Blvd.
Use the middle lane to turn Left onto Dubuque Ave.
Use the 2nd from the right lane to turn Right onto Oyster Point Blvd.
Turn Left onto Veterans Blvd.
The venue will be on the Left side.
